## NOTES ON CONTRIBUTORS

**Sarah CHEANG** works in the History of Design department at the Royal College of Art in London. Her research and teaching focuses on East Asian fashion history, gender and the body, with a special interest in fashion exchanges between China and Britain, and on fashion, race and cultural expression.

**Hazel CLARK**, is currently director of MA Fashion Studies, Parsons School of Design, The New School, New York. Her research and teaching reflect her residence in the UK, Europe, the US, Hong Kong and China, and her interests in fashion, design and culture, the everyday, slow, and fashion curating.

**Daan van DARTEL** is a museologist and anthropologist and curator of popular culture and fashion in the National Museums of World Cultures in the Netherlands. Her objective is to bring multiple perspectives to broaden audiences' views on culture and cultural expressions, and to rethink fashion theory from a transcultural perspective.

**Erica DE GREEF** is a curator, academic and lecturer. She is the co-founder of the African Fashion Research Institute and curator at large: Fashion at the Zeitz Museum of Contemporary African Art in Cape Town. **Angela JANSEN** is a fashion anthropologist who has been working on fashion in Morocco for the last 20 years. In 2012, she created the Research Collective for Decolonizing Fashion (formerly known as the NonWesternFashionConference) as a critical platform to contest the ethnocentric claim of universality of dominant fashion discourse.

KOMA Kyoko (高馬京子) is Associate Professor of the School of Information and Communication at Meiji University in Tokyo. Her research and teaching focuses on Fashion, Gender and (Digital) Media Studies, with a special interest in trans-boundaries, representation, norms, cultural appropriation, stereotype, media discourse analysis, and comparative studies between France and Japan.

Malika KRAAMER is the Curator of the Africa Collection in MARKK, Museum am Rothenbaum, World Cultures and Arts, Hamburg, Germany. She worked at several museums and universities in the UK and the Netherlands. Her curatorial and research interests are in museums and decolonisation, global dimensions of African fashion and textiles, and histories of Ghanaian cloth.

**Elizabeth KRAMER** is a Senior Lecturer of Design History at Northumbria University, Newcastle-upon-Tyne, UK. She is interested in how the materiality of garments can be used to understand cultural flows and transcultural identities, with a special interest in fashion and textile exchanges between Japan and Britain.
